

In an interactive discussion to amplify the messages for identification of nutrition priorities within the county development planning for possible financing of the Costed plan to support nutrition action cross-sectors at sub-national level, participants expressed concerns about continual interference of county constituent Legislative caucuses in the legal functions of the County Council which has the statutory authority and mandate to lead on planning of county budgeting appropriation across administrative districts in compliance with implementation of the 2018 Local Government Act.
