The meeting was conducted in the form of a community meeting and punctuated by 4 points, namely: the presentation the work in the crossreaxdsmanawellof the problem of malnutrition and famine in the DRC from the participants, that the pooling. This arrangement has allowed for better conduct of the work which resulted in recommendations and commitments emerging at the end of the work at the crossroads.

DISCUSSION

As for the discussions between participants, it must be said that we used the usual approaches to work in namely: the The participants were divided into two large groups. Each group had to work on 3 questions, groups, nutritional of the region, the challenges of malnutrition in the region, the major recommendations. This

The exercise ended by noting the points of convergence and divergence between participants in the groups where they were distributed. Immediately after this exercise the participants returned to plenary. During this pooling they presented the results of the work via their moderator supported by the secretary and all the other members of the group. After the two presentations, a summaryof the work between the two groups was made to retain the key elements from the discussions. It is this synthesis which was chosen as work for the members of the community of Ilebo

SECTION THREE: RESULTS OF THE DIALOGUE

CHALLENGES

The llebo community members discussed and emerged the following as challenges:

namely:

Lack of purchasing power in the market, due to high food prices;

Lack of necessary (nutritious) foods

Lack of drinking water

Lack of proper care by poor families

Youth and parent unemployment

These challenges are the result of group discussions supported by World Vision staff who acted as moderators.

URGENT ACTIONS

The town of llebo being in a context of precariousness due to its current isolation going in the direction of the improvement of economic and administrative governance recommendations and urgent actions essentially to decision-makers

Participants gave opinions and have sent urgent actions essentially to decision-makers

- Job creation and monthly remuneration
- -Creation and support of local NGOs in agricultural seeds, forestry and fishing tools
- Construction of health centers

AREAS OF DIVERGENCE

Most parents and adults say that this crisis is due to climate change, the phenomenon KAMUINA NSAPU and the negligence of certain parents. A minority of participants did not agree with this opinion.

GENERAL SUMMARY

The town of Ilebo hosted a nutritional dialogue that brought together around thirty people. During this meeting chaired by Mr. JEAN CLAUDE BUKASA the most. Participants took turns reflecting on key concepts the groups affected by malnutrition, the factors that have exacerbated malnutrition and hunger in the world the determinants (which the importance of good nutrition contribute to) of good nutrition Results and/impacts of improved nutrition in children.

At the end of these preliminary exchanges, there were some questions for clarification. And immediately after these aspects of clarification, the participants were divided into two large groups, each of which had to answer 4 questions (1°what is the nutritional situation of your site? 2° Talk about the challenges related to nutrition in this site? 3° what urgent actions can we lead to come to a good end of these challenges? 4° What commitments can be made for an already local management of the malnutrition in your country?). Participants were asked to highlight the divergent points and those convergent.!!

The results of the work in the crossroads were discussed in plenary, so that a synthesis emerged cast in the feedback document. Participants in the Ilebo Nutrition Dialogue further explored the issue of malnutrition in its socio-economic aspects. This is how they agreed on the issues of unemployment and those of poverty as being at the root of cases of malnutrition in their country

SECTION FOUR: PRINCIPLES OF ENGAGEMENT AND METHOD

PRINCIPLES OF COMMITMENT

In terms of commitment, the participants in this nutritional dialogue session unanimously agreed that: follows: Advocacy formulated with customary authorities to raise awareness in the community on conservation seeds, to partners who are in the area for support in seeds and agricultural tools, and also training professional of certain people on entrepreneurship and professions

METHOD AND FRAMEWORK

To achieve the organization of these dialogues, the moderators and facilitators took turns using the presentations, brainstormings, group work, plenary discussions, etc. It is the sum of these methods that has made it possible to release the content in the heads of the participants of the city of Ilebo

TIPS FOR OTHER CONVENERS

llebo participants expressed the hope that future nutritional dialogue campaigns or other activities of the genre are carried out on several scales but also over several days to allow the participation of a larger large group.
